Our tour is being handled by: Narrow Gauge Paradise of Tampa and Nurnberg

TOTAL PAYMENT: The total cost of the Tour is \$2800. per person which includes all land transportation in Europe, lodging, admissions and attractions included on the itinerary and meals as indicated on the itinerary. The tour price of \$2800. is based on a double occupancy-single travelers should add \$615 supplement. Final payment must be received by May 1, 2007.

DEPOSIT: A deposit of \$600. per person must accompany the application. Checks must be drawn on a US Bank or an International Money Order. Make checks payable

to: AMICA Germany-Holland 2007 and mail to: Liz Barnhart, 919 Lantern Glow Trail, Dayton, OH 45431. The deposit is due on February 28, 2007.

DOCUMENTS: A valid passport is required for travel to Europe, and must be carried with you at all times during the tour.

CANCELLATIONS: From the day of the signature of this contract up to 100 days prior to departure, full refund less \$125.00 per person fee. Up to 90 days prior to departure, full refund less \$175.00 per person fee. Up to 65 days prior to departure, full refund less \$325. per person fee. Less than 65 days prior to departure, no refunds can be granted.

HOTELS: Hotels per itinerary or similar basis sharing twin-or double-or queen room with private bath or shower.

MEALS: Meals are included in the tour price as indicated on the itinerary: "B" means breakfast, "L" stands for lunch and "D" for dinner.

LAND TRANSPORTATION: Land transportation will be by deluxe motorcoach with reclining seats.
